WAUKESHA - A Waukesha man was charged after two separate police chases early Monday morning involving four police agencies.

The chase went into West Allis, ending at I-41 near Lincoln Avenue shortly before 3 a.m. About 15 minutes later, West Allis police advised they had arrested Monreal, who admitted using crack cocaine earlier in the night, the complaint said. He is due in court again Feb. 8.

# Motorcyclist allegedly eluded police at speeds over 100 mph

WAUKESHA — A 35-yearold Janesville man has been charged with a felony count of attempting to flee or elude an officer after allegedly driving away from a traffic stop in Waukesha and going at speeds higher than 100 mph.

If found guilty, Jonathan Melvin could face fines up to \$10,000 and imprisonment up to three years and six months.

According to a criminal complaint filed in Waukesha County Circuit Court on Tuesday, a Waukesha police officer observed a state trooper had pulled a motorcyclist over near Highway 18 and Swenson Drive.

The police officer saw that when the trooper left the vehicle, the motorcycle driver allegedly sped away rapidly. The trooper reported he had pulled Melvin over for not using a front headlight after dark.

The police officer pursued the motorcycle weaving through lanes and not using a turn signal, according to the complaint. The suspect then allegedly accelerated to speeds over 100 mph on Bluemound Road.

The officer ultimately terminated the pursuit, but used surveillance footage from restaurants near the more information about the suspect and subsequently arrest him.

# Lad Lake resident allegedly sneaks in oxycodone

WAUKESHA — A resident at Lad Lake has been charged with delivering oxycodone to his peers.

Alexander A. Medina, age 20 of Milwaukee, has been charged with three counts of delivery of Schedule I or II narcotics and possession with intent to deliver narcotics following a March 19, 2018 incident. He faces up to 60 years in prison if convicted.

According to a criminal complaint, an officer was dispatched to Lad Lake, a care center with programs for troubled youth, regarding a report of a resident giving oxycodone pills to other residents.

The complaint says Medina admitted having the pills, but didn't tell the officer where they were. They were found following a search in a recycling bin. The officer allegedly counted nine pills in a clear plastic bag.

When asked how he got the pills into Lad Lake, Median allegedly said he had a "weekend pass" to leave and when he returned, he taped the plastic bag to the inside of his thigh. The complaint says Medina gave the pills out
